

**TERMS & CONDITIONS FOR THE FACE OF BARKING AND DAGENHAM MODELLING
COMPETITION**

1. This competition is open to residents of the Barking and Dagenham borough, except direct family members, employees of Fashion Enter Ltd, or anyone else professionally associated with the competition.
2. It is a condition of entry that all rules are accepted as final and that the competitor agrees to abide by these rules.
3. To enter the competition, entrants must be over 16 years old. Entrants must submit 1 photograph; the photograph must be previously unpublished and not have been enhanced or altered by any means. It is not permitted to submit photographs of another person. All submitted photographs must be free of any copyright and this remains the responsibility of the applicant.
